approximately 100 women each year, with current participation reaching around 200. In Ghana, our maternity ward now serves over 3,000 individuals in a remote community and can accommodate 8-10 patients at a time, providing critical care to mothers and newborns. Our Sew for Sisterhood program trains approximately 50 young women annually in sewing and beadwork, offering them both a skillset and a pathway to income generation. Additionally, our farming and entrepreneurial institutes-once fully operational-are poised to deliver widespread, long-term benefits across the communities they serve.

Our approach is both strategic and sustainable. By focusing on local ownership and long-term viability, we work to ensure that women and children continue to receive support-even in the absence of external aid. In doing so, the GO Fund aims not just to alleviate poverty, but to break its cycle entirely.
